Our STANDARD SHIPPING CHARGE for domestic orders is $\$ 11$ for up to 4 flat, unboxed items sent in an insured USPS Flat Rate envelope. Our STANDARD CHARGE for boxed shipments is a base rate of $\$ 23.00$ per order. If shipped via UPS, add \$3 per heavy or bulky item (LBoxed or weight of 3.0+ lbs as marked with an asterisk in our catalogs), plus $\$ 6.50$ per 'Giant Boxed' item (denoted with a box type of "GB" or weight $\geq 5 \#$ ), plus $\$ 4.50$ if shipping to what UPS calls a "rural" zip code ( $\$ 6.50$ for extended rural, $+\$ 14$ for deep rural). For most orders, that means $\$ 23.00$ shipping, total.
